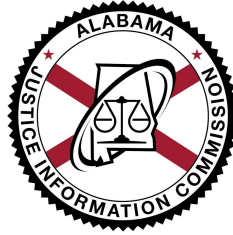

FY 2023 Alabama Forfeiture Report

We are pleased to provide the fourth annual report of civil asset forfeitures in Alabama. This initiative began through the efforts of the Alabama Law Enforcement Agency (“ALEA”), the Alabama District Attorneys, the Office of Prosecution Services (“OPS”), Alabama Chiefs of Police, and Alabama’s Sheriffs, and later codified by the Alabama legislature. This report provides a detailed summary of the reported seizures of property by policing agencies related to criminal actions and civil forfeiture actions by state prosecutors during Fiscal Year 2023. When a seizure results in a due process action in an Alabama court, the following data is entered into a database by one of Alabama’s District Attorneys or the law enforcement agency that seized the property. Within the report, you will find a summary for each circuit and seizing agency.

Background

Asset forfeiture is a civil court action used to either disrupt criminal activity by confiscating instrumentalities used to commit crimes or deprive criminals of the proceeds of crimes. In 2018, the Alabama Justice Information Commission (“AJIC”) and OPS created and created this process for reporting civil asset forfeiture actions in Alabama, which originated when state prosecutors created a standard report submission process. The Legislature adopted that process and codified it into law (Alabama Forfeiture Information Reporting Act (§§ 41-9-655 et seq, Ala. Code 1975).

Under the Act, a state prosecutor has the discretion to file for civil forfeiture of property seized by police while investigating a criminal event. Before a policing agency can seize an item or currency, probable cause must exist that the item or currency is the instrument of a crime or criminal enterprise, or that the item or currency is the profit or proceeds from a crime or criminal enterprise or were lawfully recognized abandoned property or contraband. The State has the burden of proof in every asset forfeiture action in Alabama, and the standard of probable cause for a seizure is the same as the standard used when arresting an individual for committing a crime. The prosecutor generally has a short window of opportunity to file for forfeiture after the seizure, but disposition may take considerable time. Therefore, the reported numbers associated with forfeitures during the fiscal year do not directly correlate with the number of seizures for the same timeframe. Further, multiple civil forfeiture cases may be related to the same criminal activity or multiple dispositions for property seized during a single seizure event. For example, police may seize a vehicle and currency related to a crime. After due process, the court could order the currency forfeited if the proceeds were generated as part of a criminal enterprise but could return the vehicle to the offender’s spouse, other third-party claimants, or innocent owners.

All seizure and forfeiture actions in this report are subject to due process and judicial review. Any person from whom an item or currency is seized has a right to object and an opportunity to be heard. The State has the burden to prove that the items or currency were the proceeds of a crime, lawfully recognized abandoned property, instruments or tools of criminal behavior, or contraband. All forfeitures documented

in this report are subject to public court filings, heard in open court proceedings, and subject to appellate review. The court may issue an order (1) returning items or monies seized to the owner, (2) forfeiting the items, or (3) disposing of them. Items or monies forfeited are documented and subject to an audit.

Context

It is important to view any criminal justice data, particularly forfeiture data, in context with other relevant and material information. As you review this report, please keep in mind the overall activity of Alabama's 13,000-plus sworn law enforcement officers. Statewide law enforcement is typically involved in approximately 500,000 criminal or public safety-related encounters or events leading to more than 150,000 custodial arrests. In a typical year, Alabama law enforcement will issue over 1 million traffic-related tickets or warnings. You should receive and review seizures and forfeitures in this report in the context of the overall activity and interactions of Alabama law enforcement and the public.

Automated Reporting

AJIC, ALEA, and OPS collectively developed the **Alabama Forfeiture Accountability System** ("AFAS"), a reporting system that allows Alabama prosecutors in each circuit to enter forfeitures electronically. This report is based on the seizure and forfeiture actions prosecutors entered into the AFAS system.

FORFEITURE TOTALS

The following report details seizures and forfeitures for Alabama from October 01, 2022, through September 30, 2023. Please note the following when reading this document:

- The date for each forfeiture corresponds to the earliest seizure date for the forfeiture. Some forfeitures may have been started in one month and closed out in a subsequent month.
- There may be multiple seizure events (e.g., different day of seizure or different locations) that are forfeited in a single disposition. The forfeiture count in this totals section correspond to each forfeiture case.
- Each forfeiture case will be categorized in one of the following statuses: Default, Dismissed, Litigation, Pending, Pleading or Settlement. A Default, Dismissed, Litigation, Pleading or Settlement status is considered a closed case.
